This Philanthropy Structure provides the flow of processes for funds being raised at the 2025 edition of TCS World 10K Bengaluru. It gives an overview of the philanthropic potential of the event, documenting important processes, dates, and fundraising opportunities for NGOs.

Important: Individuals can undertake crowdfunding and donate for an NGO of their choice at the back of TCS World 10K Bengaluru 2025 **only through aidbees**, and neither directly nor through any other crowdfunding platform. Funds received by NGOs directly will not be considered as funds raised through the event.

This year, there are five on-ground race categories at the TCS World 10K, Bengaluru.

		NGO Registration Fees: The NGO registration fee, which is INR 9,500/- (all-inclusive), must be paid at the time of registration, either online or via cheque/DD to aidbees, (Please note that the registration fee is non-refundable.) The registration fees can be paid by NEFT or via cheque/DD made out to Aidbees Corporate Private Limited. The payment details are as follows:

Once all registration formalities are complete, the NGO will receive an email confirmation with their page links.

Important Points.

- 1. NGO registrations for TCS World 10K Bengaluru 2025 have already commenced and they end on Friday, 18th April 2025
- 2. (a) Fundraising has already begun from Sunday, 9th December 2024
 - (b) The last date to fundraise is Friday, 9th May 2025

- 3. For donations made on aidbees platform till 31st March 2025, NGOs would be responsible to file and dispatch the 10BE forms to their respective donors no later than 19th April 2025
- 4. All donations received on and after 1st April 2025 will fall into the financial year 2025-2026. NGOs will be responsible for providing the 10BE to the respective donors.
- 5. In addition to the above mentioned registration formalities, in order to complete the registration process with aidbees for the event, NGOs,
 - (i) will be required to read and accept the data protection policy of aidbees, and (ii) pay the NGO registration fee to aidbees.
- 6. Terms and conditions as put out by aidbees at the time of NGO registration, and the event rules and regulations, will be applicable to all NGOs registered with aidbees for the 2025 edition of TCS World 10K Bengaluru.





- 7. Service charges of **3.54%** (aidbees service charges) and **2.5%** approx payment gateway charges will be levied on every donation made online (on the various NGO pages on tcsw10k.aidbees.org, or offline (via cheques/DD/NEFT).

 Cash WILL NOT be accepted by aidbees.
- 8. Donations made will be directly transferred to the NGOs' account, after deducting the service charges above, via the payment gateway partner, Razor pay; aidbees will not hold any donations in their bank account.
- 9. aidbees will forward all legally required details of donors to respective NGOs within 15 days of the donations made.
- 10. Donations made will not be refunded for reasons whatsoever.
- 11. Procam International (Event Promoter) will oversee all event registration and event related queries.

VISIBILITY OPPORTUNITIES FOR THE NGOS

- Each NGO will be mentioned under the 'Philanthropy Section' of the event website, with a hyperlink directed to the NGO page on the aidbees website.
- 3 NGOs raising the highest funds during a week (Thursday to Wednesday) will be promoted on event social media platforms and featured on event's website, leading up to 9th April 2025. Such NGOs must have fundraised a minimum of INR 25,000 in the week defined.
- Select Showcase: Selected stories will showcase those NGOs who have chosen
 to utilise the platform and have fundraised a minimum of INR 50,000, and
 reached out to donors in a unique and different manner. Content needs to be
 provided by the respective NGO.
 - *Stories will be selected at the sole discretion of the Event Promoter and aidbees's social media team.
- 20-second AVs of the highest fundraising NGO in each cause category will be played on rotation basis at the Event's Media Center and at the Mirchi Get Active Expo. The NGO should have raised a minimum of INR 25,000 by 1st April 2025. AVs need to be provided by the NGO.





- Top 10 fundraising NGOs as on 1st April 2025 will be featured**
 - (a) on Wall of Change at the Event Media Center, Expo and within the Procam Marquee,
 - (b) on the Philanthropy leaderboard on television during live telecast.
- Logo/name on the Charity Corridor on the race route, provided a minimum of INR 25,000 is fundraised by NGOs on or before 1st April 2025.*
- NGOs having at least one corporate company supporting them will have access to the Corporate Tent to interact with the supporting corporate (not more than 2 representatives per NGO).

Note: *Subject to NGOs raising a minimum of INR 25,000 on or before 28th March 2025. If no high-resolution logo is provided, the name of the NGO will be carried.

** To determine the top 10 NGOs, only funds raised by 1st April 2025, including cheques/DD cleared in aidbees bank account, will be considered.





GENERAL BENEFITS OF PARTICIPATING IN THE EVENT

- The NGOs participating in the TCSW10K 2025 will benefit by associating with a premiere sporting event of the country. The event will help in increasing NGO visibility and help cement relationships between individuals, corporates and NGOs.
- The NGOs corresponding to the Top fundraising individuals will be invited for the Gala Dinner of the TCSW10K Philanthropy Awards.
- aidbees will be empowering the participating NGOs in the TCSW10K 2025, by amplifying their social media presence and promoting the work of the NGOs through creative posts.

FIVE (5) WAYS FOR NGOs TO RAISE FUNDS AT TCSW 10K, BENGALURU 2025

The 2025 edition of TCS World 10K Bengaluru presents 5 (Five) ways in which NGOs can raise funds. These modes are further elaborated in this structure. We encourage NGOs to recognize their own strengths and choose all or a combination of modes which will work best for the organization.

1. NGO Pages

On registering with aidbees for the event, a personalized page for each NGO is created on the aidbees website **tcsw10k.aidbees.org**. The page features the NGO's appeal, total amount being raised, fundraisers, and a donate button for individuals to directly donate on the page.

2. Individual Fundraisers

Individuals who are motivated and are willing to raise funds for the participating NGOs can do so by registering themselves on the aidbees platform. The fundraisers are free to support any cause of the NGOs as per their interests. The NGOs are listed on the website and based on the interest, one can start fundraising for them.

3. Charity Bibs

These are running slots exclusively reserved for NGOs participating in the TCSW 10K event. These bibs enable the NGOs to engage with their current supporters and prospective donors, enhance visibility for their cause, and generate funds for the same. These Bibs, along with other opportunities, serve as a means to encourage philanthropy by empowering NGOs to gather funds via TCSW 10K. Runners can avail of these Bibs by making a donation to an NGO of their choice that is registered for the TCSW 10K, Bengaluru 2025.

4. Top Up Donations

To inspire runners to give back for a meaningful cause while registering for their run, the registration process allows all runners to donate towards a common pool for participating NGOs. It also enables runners to create fundraising profiles if they want to raise funds for an NGO. During registration, runners can donate to this pool as "Top Up Donation" and support the causes the NGOs are raising funds for.







5. Corporate Participation

The corporates who are willing to participate and make a difference can join in with their runner teams. They can raise funds for a noble cause and support an NGO of their choice by registering through the aidbees platform.

Important: Please note, Procam International blocks a certain number of running places (of each race category) for philanthropy with aidbees, who in turn further assigns these for individual fundraisers, corporate participation and charity bibs. These philanthropy running places will be available till the last date mentioned in timelines ahead, or until running places of desired race category last, whichever is earlier.







NGO PAGES FOR THE TCS WORLD 10K, BENGALURU 2025

All registered NGOs on the TCSW-aidbees website have personalized pages for their campaign. These pages showcase the NGO's work and appeal to their donors along with photos & videos of the projects they are raising funds for.

The main features of the NGO pages are: **Donation**: A "Donate" button on the NGO page allows for online donations. Interested individuals can visit the NGO's page and contribute directly using this button. All donation amounts are transferred directly to the NGO's account; aidbees retains only the service charges and payment gateway fees. Donors' names are displayed at the bottom of the page under "Supporters".

INDIVIDUAL FUNDRAISING

Committed individuals raising funds for a cause of their choice are the backbone of the philanthropic endeavor of the TCS World 10K Bengaluru 2025. An individual fundraiser is someone who seeks to make a difference by raising funds for an NGO to support a cause they are passionate about. aidbees supports these individuals by providing an efficient and empowering platform to raise funds. As the fundraising amount increases, individuals can achieve higher levels of recognition.

Fundraisers begin by creating their own fundraising page on the aidbees TCSW website-tcsw10k.aidbees.org. These pages are user-friendly, feature-rich, and free to set up. All online donations made through these pages are automatically disbursed to the NGOs directly.

Process of Becoming a Fundraiser

- 1. Register here on <u>tcsw10k.aidbees.org</u> > Individual Fundraisers
- 2. Click on Fundraiser Registration to complete the initial process & make your account
- 3. Re-login with username and password
- 4. Create your page by filling in the appeal and select an NGO to raise funds for
- 5. Share your campaign with your network to start raising funds!

Now your page is ready to be shared with your peers, friends and family!







IMPORTANT DETAILS:

Any individual, whether running in the race or not, can use the philanthropy platform of the TCS World 10K Bengaluru 2025 to support an NGO of his/her choice and raise funds, therefore. One can start a fundraising page on the aidbees-TCSW10K website and become a 'Fundraiser'.

What Individual Fundraisers* can look forward to:

- Recognition will be given on the aidbees website to the top 10 individual Fundraisers every month.
- Top two Fundraisers, provided they have raised a minimum of INR 1,00,000 by 9th May 2025 will be featured in the Event Docket.
- Fundraisers who have raised more than INR 75,000 will be listed in the Event Docket released at the Philanthropy Awards.

Categories of Individual Fundraisers

YOUNG LEADERS

This fundraising category celebrates young philanthropists and their commitment to make a difference.

Fundraisers below the age of 18 years (as on 27^{th} April 2025) and fundraising a minimum amount of INR 75,000 for their chosen NGO/s fall under this category and are entitled to the following incentives.

Young Leaders reaching their minimum target by 4th April 2025.

- Top 10 Young Leaders will be featured on the Wall of Change at the Get Active Expo and the Event Media Center.
- Event tees to top 10 Young Leaders (subject to available sizing).

^{*}Person who doesn't fall under the Young Leader or any of the Kindness categories.

Young Leaders completing their minimum target by 9th May 2025.

- Top 10 Young Leaders get a shout-out on social media from the Event.
- Appreciation Certification from the Event recognizing their fundraising efforts.
- Mention in the post Event Docket. The highest fundraising Young Leader will be featured in the Event Docket.
- TCSW10K 2025 Philanthropy Award to the top 2 fundraising Young Leaders.
- Invitation to the top 5 fundraising Young Leaders at the Philanthropy Awards Night.
- Top 2 fundraising Young Leaders to receive signed memento of International Event Ambassador

Important: Where a Young Leader raises funds more than INR 1.50 lakh, s/he will be entitled to the benefits reserved for the relevant Kindness Fundraiser category/ies.

CHARITY BIBS

To enable philanthropy, special running slots (Bibs) are reserved for NGOs participating in TCSW 10K, 2025. These are unique bibs that allow runners to support a cause and NGOs can sell these bibs at a higher cost to willing runners.

Runners can obtain them directly from the NGOs to support their causes. TCSW10K attracts numerous participants but has limited slots; availing of Charity Bibs is the only option for runners especially when general registrations fill up quickly. There is a minimum donation amount per race category to ensure fairness among NGOs. NGOs can request higher amounts from donors. Runners with Charity Bibs proudly display the NGO's name on their running bibs, demonstrating their support for the cause.

- The charity bibs are issued on a first come first serve basis to the NGOs. The NGOs can ask for more bibs till the charity bibs are available with the organisers.
- The NGOs will have to pay a flat fee of INR 300/- to aidbees for every bib they block for the runners (non refundable)
- The donation paid by the donor for a charity bib will go only via the NGO page on the aidbees-TC\$W10K website (https://tcsw10k.aidbees.org/). The NGO will have to inform aidbees via email of the donation received. After the email confirmation is done, only then will aidbees release the URL and code for the runner to proceed with registering themselves for the race. The NGO will be responsible for issuing a donation receipt.
- The NGOs should sell the bibs for not less than the amount arrived upon by the Philanthropy Partner. The NGOs can decide the cost of the bibs but it should be equal or more to what aidbees has suggested.

Allocated Bibs

In this edition, each participating NGO can utilise as many Bibs as they require on a first come first served basis. But only one bib will be issued at a time to new NGOs. They can convert this Bib to any race category they require until Bibs of that category are available with aidbees. A new bib will only be allocated once an NGO secures a donation and uses the previously allocated bib.







Charity Bib Retention Amount

aidbees has set a minimum donation amount for Charity Bibs. The race category-wise minimum donation will progressively increase as per the table below:

Process for NGOs to reserve Charity bibs:

Important:

*Only 1 bib is to be allotted at a time to a new NGO

*NGOs falling in the Gold, Silver, or Bronze category in the previous editions will receive 2 charity bibs at a time.

Step 1:

Visit the Charity Bib page and fill in the required details, including Bib Type.

Step 2:

Complete the payment using the provided QR codes and upload the payment details via the designated link.

Step 3:

Aidbees will verify the payment and reserve the bib accordingly.

Step 4:

New bibs will not be issued to the NGO until the reserved bibs are utilized.





Charity bib Runner Registration Process

Step 1: Request a Charity Bib:

Charity runners can request a bib through the official website https://tcsw10k.aidbees.org/. This can be done either via the "Charity Bib" tab or directly through the NGO's page.

NGO Verification: The NGO receives a notification of the runner's request and will verify the inquiry.

Step 2: Complete Donation Process:

The donation paid by the donor for a charity bib will go only via the NGO page on the aidbees-TCSW10K website (https://tcsw10k.aidbees.org/). The NGO will have to inform aidbees via email of the donation received. After the email confirmation is done, only then will aidbees release the URL and code for the runner to proceed with registering themselves for the race. The NGO will be responsible for issuing a donation receipt.

Step 3: Issuance of Paid Code:

After the donation is confirmed, the runner will receive a paid code & registration link to complete their run registration. If the NGO is paying the run registration fees on behalf of the runner, they must inform aidbees in advance and provide the payment details for the run registration.

Step 4: Finalize Run Registration Process

Runners must use the provided code and link to finalize their run registration. The registration process is managed by the event promoters on the official website: https://tcsworld10k.procam.in/. A separate run registration guide will be provided along with the code.









Step 5:Bib Collection:

Upon registration approval, the runner is assigned a Bib, which they can collect at the Expo from the aidbees counter.

Please Note

*All 10K timed runners must complete their run registration by selecting the timed run option. (If they are part of the timed run format) No requests to add a timing certificate later on will be accepted or processed from the backend.

*aidbees does not accept physical runner forms for either online or offline donations.

Charity Bibs Collection Process

All the Charity Bibs obtained through an NGO will be given to the NGO on the first day of the Expo at the aidbees counter for onward distribution to their runners. (NGO needs to submit prior mail confirmation OR letter from runner). Charity Bib runners need to connect with their NGOs for their Bibs.

In case an NGO is unable to facilitate the same, Runner can submit a letter/mail to aidbees requesting for distribution of their Charity Bibs from the aidbees counter at the Expo. Their runners will have to come to the Expo to collect the same from the aidbees counter.







TOP UP DONATIONS

Top Up Donation is an avenue to donate towards a cause while registering to run at the TCSW10K Bengaluru 2025. The registration process allows all runners to donate towards a common pool for participating NGOs. It also enables runners to create fundraising profiles if they want to raise funds for an NGO. The donations in the shared pool will be distributed among NGOs based on privilege levels attained (explained ahead in this document).

- For the TCS World 10K Bengaluru 2025, aidbees has engaged a partner organisation as the Top Up Donation Facilitator.
- The Top Up facilitator shall be responsible to issue donation receipts to the donors within 15 days of making a donation. Additionally, the NGO shall be responsible to issue a 10BE certificate to the donor by 31st March 2025 (if the donation is made prior to 31st March 2025) or by 9th May 2025 (if the donation is made after 31st March 2025).
- In order to process donations made and to issue the necessary receipts and tax exemption certificates, required information of the donor as required by law, viz. name, address, email id and PAN details, will be shared with the facilitator organization for this limited purpose.
- Only Indian residents residing in India will be in a position to make a top-up donation.
- Donations once made are non-refundable, regardless of runner registration acceptance.
- Since this donation is handled outside of aidbees platform, a deduction of 11.72% will be made as payment gateway charges and processing fee to Top Up Facilitator. The organisation shall disburse the remainder donation amount, as a grant, in accordance with and on the instructions of aidbees, basis the privilege levels achieved by the NGOs. Within 7 days of such disbursement of funds to the NGOs, the facilitator shall give aidbees the proof of disbursal.
- However, for disbursements to be made, the NGOs awarded with the said grant will
 have to submit a letter of purpose for donation to aidbees and the facilitator.
- A letter of Utilisation within four (4) months of receiving the grant shall be submitted to aidbees and the facilitator organisation.
- NGOs are expected to thoroughly go through all information mentioned on the event website regarding runner registration on https://tcsworld10k.procam.in/.






Top Up Donation Grant for participating NGOs

To reward participating NGOs that make full use of the aidbees and TCSW10K platforms, we will identify indicators that translate into levels of privilege for each NGO. These levels will determine the NGO's standing for the top up grant at TCSW10K 2025. The privilege level is not a rating of the NGO's work but simply reflects their level of participation. NGOs can aim to improve their privilege level until 9th May 2025. However, race day benefits will be based on the privilege level determined on 29th March 2025. Each indicator below carries 1 point.

These points can be earned through three categories: Fundraisers, Charity bibs and Corporates. A maximum of 12 points can be earned by an NGO through this system.



Bronze - 3 to 5 Points | Silver - 6 to 8 Points | Gold- 9 to 12 Points

CORPORATE TEAM PARTICIPATION

The **CORPORATES TEAMS** category is specially designed for companies to field teams of employees at the TCS World 10K Bengaluru and support a cause or NGO of their choice through charitable contributions. This event provides an opportunity for companies to engage employees, invest in their overall well-being, and raise awareness for the cause supported by the company.

Companies can choose to support any of the NGOs listed with the event's philanthropy partner, **aidbees**. If a company's preferred NGO is not registered for the event, aidbees will assist the NGO with the registration and onboarding process.

Fielding a Corporate Team

At the TCS World 10K Bengaluru 2025, companies can choose to field corporate teams of following sizes and make an upfront (non-refundable) contribution in favor of the chosen NGO. Additional employee participation cost will be separate as below:

- If a corporate wants to increase the team size apart from the above mentioned categories, it can add a maximum of 5 members to the team and have to pay an upfront contribution of INR 10,000 for each member added to the team.
- Donations once made will not be refunded under any circumstances whatsoever. The amounts mentioned above do not include the event run registration fees for individual team members. These need to be paid additionally, depending upon the race category chosen by individual team members, to the event promoter (via cheque/ DD/ Bank Transfer) in favor of 'Procam International Pvt. Ltd.'. The applicable run registration fees must be paid to Procam on or before the deadline (to be informed) and it will be over and above the service charges retained by aidbees.









SERVICE CHARGES OF AIDBEES

Race Day Visibility

- Top 10 contributing companies will be featured as a leaderboard on television during a live telecast of the race.
- Company name will be acknowledged in the Corporate Tent.
- In addition to the above, Corporate Teams contributing **INR 6 lakh** and more for their chosen NGO, will have their presence with the Charity Corridor on race route, featuring their name and the NGO chosen.
- Furthermore, 2 senior management representatives of companies (CXOs) contributing INR 10 lakh and above in the 2025 edition will be hosted in the Grand Stand on race day and representatives contributing over INR 20 Lakhs will be hosted on the Procam Marquee
- Race day photographs for top 2 fundraising members in a Corporate team (provided captured by event's official photographer). To be eligible for this, the team member must have raised a minimum of INR 1,00,000 for his/her chosen cause and such funds must have been submitted and reported to aidbees on or before 10th May 2025.
- All contributing and fundraising companies will be mentioned in the event docket.
- The top two contributing companies and the top two fundraising companies (provided their employees have collectively raised a minimum of INR 1,00,000) will be prominently featured in the Event Docket, published after race day.
- For a larger number of employees participation, fundraising workshops will be conducted by aidbees and the beneficiary NGO upon prior request.
- Easy single point collection of Bibs for all employees irrespective of race category from the aidbees counter at the Expo.


Corporate Tent

 On race day, event promoters will set up a dedicated tent in the holding area exclusively for Corporate Teams participating through philanthropy. This tent will be the perfect opportunity for employee engagement & networking. The tent





will also be the one stop destination on race day for employees to collect their medals and refreshment. The highlight of this tent will be enjoyable activities such as games, Zumba sessions, photo booths, team challenges. These offerings ensure that corporate team participants have a memorable and unique experience at the TCSW 10K 2025 Run ,enhancing their overall event participation beyond the run itself.







Philanthropy Page & Onboarding Process for Corporates

Step 1	If the corporate has participated in the 2023 or 2024 edition of TCSW10K, please login with your existing credentials or email tcsw10k@aidbees.org for the same.
Step 2	If you are participating for the first time, please sign up as a corporate: https://tcsw10k.aidbees.org/corporate-registration
Step 3	Upon receiving confirmation from the corporate entity regarding TCSW team participation, the corporate representative must proceed to create a profile on www.tcsw10k.aidbees.org under the corporate partner section. They should provide all necessary details and select the supporting NGO
Step 4	Make the upfront contribution basis the team size (as given in the table (Pg. No 22) directly to the chosen NGO. The NGO needs to submit payment proof to aidbees to further process the team's registration.
Step 5	Once the contribution is made, the NGO needs to introduce the corporate Point of Contact (POC) to the philanthropy partner, aidbees, for the run registration process.
Step 6	Corporate runner run registration applications are handled through the official online portal managed by the EventPromoter - Procam International Pvt. Ltd. Runners can register using company-specific unique codes. *Detailed login process for team run registration will be sent to the POC in a PowerPoint presentation, covering employee registration. *If a runner is participating in the timed run, they must submit a timing certificate with aidbees before completing their application.
Step 7	The last date for the company SPOC to finally submit the team run registration is 14th March 2025. No changes will be accommodated in the individual registrations post this date. Please note, running places for a desired race category by team members can be availed if only until running slots are available or 14th March 2025, whichever is earlier.





Important:

- Please note, the NGO contribution does not include the event run registration fees for individual team members. This fee must be paid separately by the corporate entity, depending on the race category chosen by each team member, to the event promoter (via cheque/DD/Bank Transfer) in favor of 'Procam International Pvt. Ltd.' on or before Wednesday, 4th April 2025
- ► The run registration fees must be remitted to Procam International no later than 4th April 2025 failing which, Procam International has the right to withhold the running number bibs of the relevant corporate team.
- ► NGOs must pay the services charges as mentioned above to aidbees no later than Friday, 7th March 2025
- Where employees of companies wish to further fundraise for the NGO supported, standard service charges of 3.54% (3% being aidbees service charges) and 2.5% payment gateway charges will be levied on every donation made online (tcsw10k.aidbees.org) or offline (cheque/DD).
- ▶ Donations and upfront contributions made by companies will not be refunded for reasons whatsoever.
- ▶ Run registrations of individual team members will be subject to the Entry Rules & Regulations of the TCS World 10K Bengaluru 2025.
- ► Employees from participating corporates can further enhance their philanthropic engagement in the TCSW10K by fundraising for causes and NGOs of their choice from the listed options.

Fundraising

Fundraising for a cause is a fulfilling and gratifying experience, offering a valuable opportunity to contribute to underserved communities.

For NGOs, employee fundraising presents an opportunity to engage new fundraisers who support their cause. NGOs can request a session with the Corporate SPOC to explain their project and requirements to employees, fostering direct interaction.



Upon request, aidbees can also participate in these sessions to provide guidance on the fundraising platform for employees.

Important: Employee Fundraising is only applicable if the said employee's corporate has fielded a Corporate Team supporting an NGO.

The process for raising funds as an employee fundraiser is the same as Individual Fundraiser with some added benefits mentioned below:

- Top 3 employee fundraisers get a shout-out on social media from Event & aidbees.
- Top 5 Employee fundraisers who have raised above INR 1 Lakh on Company name will be featured in the special section of the Corporate Tent on race day.
- All other privileges are applicable to employee fundraisers as per their achieved fundraiser level.
- The highest individual fundraiser from a corporate team, who raises a minimum of INR 1,00,000, will receive an award at the Philanthropy Awards Night.
- Feature in the TCSW 10K, 2025 Event docket.









Employee Matching Grant - New Addition

The concept of a matching grant for the TCSW10K Run is where employees collect donations for a dedicated NGO, which is then matched by their corporate. A single donation will be made by the corporate/SPOC on behalf of the employee(s) via the aidbees website. The last date for the company to donate the matching grant and be eligible for benefits is March 15th, 2025. The respective corporate will have to collect all Employee grant donations and make a one time payment via the aidbees- TCSW website. Platform charges apply as mentioned earlier. Minimum amount raised via employee and corporate has to be- INR 50,000 to avail benefits.
